Would your party support global initiatives to ban wildlife markets and curb the global and domestic commercial trade in wild animals, products and derivatives that could contribute to the spread of zoonotic diseases, biodiversity loss and/or animal suffering?

Yes No Additional comments:

At CITES 2019, our Government supported several proposals for the protection of certain species of wild fauna and/or flora against over-exploitation through international trade. Canada voted in support of a proposal to add Shortfin Mako to Appendix II of CITES, which was adopted by a vote of 102 support, 40 oppose and 5 abstain.

Canada supported a proposal to transfer the Zambian population of African elephant to Appendix II of CITES. Canada also participated in a consensus-based determination amending an existing CITES Resolution that encourages the closure of all domestic elephant ivory markets. Canada opposed a proposal that would have removed elephant populations from Appendix I, thereby maintaining their protections under CITES.

Would your party support establishing, and adequately funding, a comprehensive and transparent system for monitoring the import, export and sales of live wild animals and their parts and derivatives in Canada?

Yes No Additional comments:

Canada already has a robust permitting system that regulates the import, export, or re-export of species listed under the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES). The Liberal Party of Canada is open to consulting with stakeholders to determine the need for additional mechanisms to monitor the import, export, and sales of wildlife in Canada to build on the existing framework.

Would your party support working with provinces and territories to mitigate inherent risks to public health, animal welfare and our natural environment by harmonizing and strengthening regulations to significantly reduce captive breeding, transport, and the physical and online trade in wild animals?

To that end, the Liberal Party of Canada has passed several important pieces of legislation to meaningfully improve animal welfare, including Bill S-203, *Ending the Captivity of Whales and Dolphins Act*, Bill C-84, *An Act to amend the Criminal Code (bestiality and*

The Liberal Party of Canada is committed to policies that protect the health of Canadians and animals. The Federal Action Plan on Antimicrobial resistance was launched in 2015 and multiple federal departments and agencies have since been undertaking significant work to develop a strong national response to antimicrobial resistance. Since then, 'Tackling Antimicrobial Resistance and Antimicrobial Use: A Pan-Canadian Framework for Action' was jointly released by our Party in 2017, through consultation with cross-cutting public and private sector stakeholders. We are also committed to continuing our leadership nationally through collaboration with provinces and territories, farmers, and other stakeholders to increase surveillance, stewardship, and innovation- and also in international efforts to address AMR, including at the WHO, UN, G7 and G20.

The Liberal Party of Canada is committed to supporting Canada's agricultural industry and providing our farmers with the support they need to transition to more sustainable agriculture systems, particularly with implementing climate-smart agriculture initiatives to reduce greenhouse gas emissions. The Party's *A Healthy Environment and a Healthy Economy* climate plan included several investments to advance sustainable agriculture in Canada, including the \$165.7M Agricultural Clean Technology Program (ACTP) to support Canadian farmers with the research and adoption of clean technologies. The Living Labs initiative is a \$185 million, 10-year program which brings together farmers, scientists, and other partners to develop new beneficial management practices directly on farms in order to increase sustainability and enhance climate resilience. And, the Party's Budget 2021 announced the Agricultural Climate Solutions fund of \$200 million over 3 years to directly support farmers in adopting beneficial management, cover cropping and rotational grazing practices. The Liberal Party of Canada is open to considering further investments to help farmers transition to support higher-welfare and more sustainable agriculture systems.
